INFORMATION FOR AMATEUR RADIO LICENCE CANDIDATES

The next scheduled Course is on March 11 &12.

Below please find our procedures and prerequisites.

Abbreviations: ARNSW = Amateur Radio NSW, ACMA=Australian Communications & Media Authority, AMC=Australian Maritime College WIA=Wireless Institute of Australia

- There are no educational, age, citizenship or residential prerequisites.
- Morse code knowledge is not required.
- Any applicant who requires any form of <u>Special Assessment</u> in completing their exam or practical assessment must notify us of the details when registering.
- What to bring with you
- A Government photo Identity document (e.g. Drivers Licence, valid Passport or Government issued Photo Identity Card).
- A calculator (candidates are permitted to use calculators during their exam provided that they are not wirelessly connected or part of a phone etc.).
- A working pen (and maybe a spare).
- (For Foundation Licence Candidates), The Foundation Licence Manual
- Copies of any previously successful Amateur Licence Assessments (if you partly qualified for a licence previously).
- Radiocommunications Licence Conditions (Amateur Licence) 2015 --Latest Compilation (if you are sitting for the Practical Assessment which is usually part of the Foundation Licence assessments .)
- Your Lunch

- The ACMA will send an invoice for (approximately) \$84 for the first year's licence fee upon successful completion of the assessments and review of the documentation. Subsequent years' annual licence fee will be invoiced by the ACMA directly and is approximately \$55.
- CANCELLATION FEE \$20: If you cancel more than a week before the course no cancellation fee will be charged, otherwise \$20. The balance of your registration fee will be refunded via the same method as you used to pay. If we cancel we will refund all amounts received.
- The <u>registration form</u> can be completed and emailed to <u>education@arnsw.org.au</u>
- There are limited places and no guarantees can be made of places. We must have advance notice of your intention to attend because if we don't have sufficient pre-booked candidates we may cancel or postpone the course. If we have too many, you will not get a place.

Foundation Licence Handbook

If you are a Foundation Licence candidate, you should obtain and read the <u>Foundation Licence Handbook from the WIA</u>. You should read this book at least once before the course, however, some individuals have successfully obtained licences by just attending the course.

You might benefit by watching some of the Foundation Licence Tutorials (especially the one on Practical assessments) on <u>The School of Radio &</u> <u>Electronics</u> website. You don't have to attend the course if you feel ready to sit the assessments.

<u>Candidates for Standard & Advanced Licensees</u> will have studied separately (often via the online <u>Radio & Electronics School</u>) and need to pass the Theory

exam, the Regulations exam and the Practical Assessment. If they are upgrading from a Foundation or Standard Licence they need not complete the Practical Assessment again.

Advanced candidates with Standard Licences need only sit for the Advanced Theory assessment, as the Regulations Assessment and Practical Assessment for Standard and Advanced Licensees are the same.

All are welcome to attend the Foundation course because there are practical exercises during the course. This is included in the examination facility fee.

The weekend Foundation Licence course starts on Saturday at 08:30 AM until approx. 5 PM. It continues on Sunday from 08:30 AM to approx. 5 PM (sometimes ending a little later depending upon the number of candidates). *Please arrive by 08:30 am each day.*

<u>Our Location</u> is <u>63 Quarry Road, Dural</u>. There is parking available. Click <u>HERE</u> for manual directions.

The course comprises one and a half days followed by assessments. The coursework will be based on the Foundation Licence Handbook, plus practical exercises, including radio station assembly and on-air procedures.

LUNCH: You should bring your own lunch.

Assessments

Foundation Assessments start about after lunch Sunday. However, Standard & Advanced assessments might be able to take place on Saturday or Sunday morning depending on the availability of sufficient assessors and free space. We will notify you in advance.

ACMA LICENCE APPLICATION

All papers will be sent to the AMC for marking together with the completed ACMA application for an Amateur Radio Licence. If you are successful the AMC will issue you a competency certificate and automatically forward the licence application to the ACMA. Currently, this could take between two to six weeks.

ACMA will then send you an invoice for approximately \$84 for the first year's licence fee. After ACMA receives the fee, your licence entry in the <u>ACMA</u> <u>database</u> will show "Granted" and you are then authorised to transmit.

When making your application to the AMC/ACMA you can request which callsign you would like to be issued rather than receiving the next available. (If you wish a particular callsign, we suggest you also include an alternative in case your first choice has been allocated to someone else before your application is processed.)

From late 2020, any licensee in NSW can apply for the VK2 prefix plus any 3 letter suffix that is available e.g. VK2YES.
